#### I. Introduction, Vision, Mission, and Values

#### Introduction

The National Accreditation Commission of Schools and Colleges (NACSC) is an autonomous body registered under Act 2 of 1882 with the State Government of Karnataka, India, under the provisions of the Amended NACSC Governance Act, 2016. NACSC operates independently as a national accreditation and regulatory authority, ensuring compliance with quality standards while remaining outside the purview of the government.

NACSC provides accreditation services for PreK-12 schools, higher education institutions (HEIs), and specialized academic programs, including joint degree programs, hybrid learning, blended learning, and distance learning programs. Our accreditation framework aligns with global quality standards such as ESG (EHEA), CHEA (USA), QAA (UK), and TEQSA (Australia), ensuring international recognition and academic mobility.

In 2022, NACSC adopted a robust accreditation framework based on ESG, WFME, AMSE, ORPHEUS, and NAAC to enhance trust and recognition across higher education systems. This includes the accreditation of PreK-12 schools, higher educational institutes, programmes and specialized programme Standards in Medicine and Healthcare, harmonized with the Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG, 2015) and developed on the basis of the World Federation of Medical Education (WFME) International Standards. NACSC also accredits doctoral programs based on the ORPHEUS-AMSE-WFME-NAAC Standards for PhD Education, ensuring rigorous quality benchmarks and alignment with international best practices.

Following the enforcement of the Amended NACSC Governance Act, NACSC revised its quality assurance methodology to align with the Bologna Declaration and the Lisbon Strategy, ensuring compliance with ESG - 2015 standards.

The board is planning to initiate external peer reviews from organizations such as EQAR, ENQA, WFME, and IREG to maintain accreditation integrity and relevance.

Driven by integrity, professionalism, and innovation, NACSC supports institutions in meeting evolving educational demands in an interconnected world.
